- Check in at predetermined scheduled intervals with the Foreman or Administrator to let them know your progress throughout the day and when you expect to return.
- Check in upon completion of the work or upon return to the shop or office.
- The Foreman may put limitations on high risk activities.

2.08 When workers are working alone outside of regular hours, the following actions must be taken:

- Worker must be able to have radio contact with the office when possible and cell phone coverage.
- Develop a plan. Include where, when and how.
- Ensure you have sufficient supplies such as food, water, safety equipment, tools, etc. In the winter, ensure you also have a

blanket, extra clothes, matches, candles and other winter emergency supplies.

- A back-up buddy must be available to respond if necessary.
- Check in at predetermined scheduled intervals with your backup buddy, Foreman or Administrator to let them know your progress throughout the day and when you expect to return.
- Check in upon completion of the work or upon return to the shop or office.
- The Foreman may put limitations on high risk activities.
- 3.03 Weather days that do not permit grading, employees may be sent home by the Foreman and time made up in excess of ten hour work days or on weekends with Foreman's approval. If you choose with Foreman's approval to work on a Stat Holiday you will not be paid above your regular working wage.
- 3.09 If an employee is working on a road that causes an unsafe condition, the employee must stay as late as necessary to make the road safe again.
- 15.01 Every accident or incident, no matter how slight it may be, must be reported to the Council, Foreman or Administrator immediately.
