That the gravel crush for 2022 is cancelled and advertised for tender again for a start day of April 15, 2023. Volumes shall be 30,000 yards of 3/4", 10,000 yards of 1 1/2", plus 2" minus at the Scott Pit (NE-5-10-22 W3), and 20,000 yards of 3/4" at the Glennie Pit (SE-29-9-24 W3). The gravel must meet the 106 traffic gravel spec. Tenders must include cost per cubic yard of crushed product, stripping costs, mobilization, fuel surcharges and all other fees. The gravel crushing must be completed by May 31, 2023 or as soon as possible thereafter pending weather conditions. The Municipality shall hire a third party to measure the pile once the crushing is completed and take

samples of the product to meet required spec. Tenders are to be received at the RM office by 12:00 p.m. on Tuesday, November 8, 2022.
