Grader Price - \$628,629.67 plus fees and taxes

Value of Trades - \$280,000.00

Amount to be Financed (After Taxes and Trades) \$387,350.63, with 60 monthly payments of \$7,155.48.

FUEL CLAUSE POLICY 8.1 Resolution: 25-080

Torban Peterson

That the Fuel Clause Policy is amended as follows: 3.1 This policy is based on:

a. A base price of \$1.50 per litre municipal cost for diesel fuel

- b. 22 yd³ payload at \$0.39 per yard per mile, where the fuel cost would equal 25% of hauling costs
- c. Fuel Mileage = 1 litre per mile driven (loaded and return)
- 3.2 Where fuel prices increase above the base price, compensation will be adjusted by the percentage increase multiplied by the percentage of hauling costs.

Example: 20 mile haul (40 total miles total with return trip)

1. Calculate the gross revenue -

22 yd² x 20 miles x \$.39 = \$171.60

2. Calculate fuel cost

40 miles x 1 mile/mile x 1.50 = 60.00

3. Calculate the Fuel Cost as a percentage of Gross Revenue

\$60.00/\$171.60 = 34.95%

4. Calculate the increase in fuel as a percentage

If fuel is \$1.58: \$1.58 - \$1.50 = \$.08

.08/1.50 = 5%

5. Calculate revised haul rate

Base haul rate x percentage of fuel cost x fuel cost increase percentage

 $$.39 \times 34.95\% = 13.63 $13.63 \times 5\% = $.68/yd^3/mile$
